

A Bill to Help the Immigrants of the United States

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. All undocumented immigrants without criminal records shall have their
3 application fee for U.S. citizenship waived. Those denied citizenship status within ten years of
4 entering the U.S. shall be granted legal status and will be allowed to legally work within the U.S.

5 SECTION 2. Immigrants shall not be discriminated against based on race, religion, sex, age,
6 income, or ability. All persons seeking citizenship shall be required to complete the necessary
7 applications and background tests.

8 SECTION 3. The US Department of Immigration will be responsible for facilitating this
9 legislation.

10 SECTION 4. This legislation will take effect one year from passage. All laws in conflict with
11 this legislation are hereby declared null and void.

A Resolution to Ban the Advertising of Violent Video Games

- 1 WHEREAS, Modern technology, including virtual reality and the metaverse, has made games
- 2 more lifelike over time; and
- 3 WHEREAS, Advertisements for videogames are not always preceded by warnings to the
- 4 viewers about violence or potential triggers, and tend to fail to allow sufficient time for
- 5 potential viewers to avoid viewing harmful content; and
- 6 WHEREAS, Video games in which war or violence is being depicted can be triggering to
- 7 those with P.T.S.D. from real battles, veterans, and persons sensitive to violence; and
- 8 WHEREAS, Violent actions in video games may normalize violence in real life; now,
- 9 therefore be it
- 10 RESOLVED, By the Congress here assembled that all advertisements for video games be
- 11 banned from depicting potentially triggering images of war, combat, or violence, or audio
- 12 from combat or guns firing.

A Bill to Support the Shift to Sustainable Energy

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. Fossil fuel companies will receive performance-based grants to shift away
3 from fossil fuel energy production to renewable energy production.

4 SECTION 2. Fossil fuel energy shall be defined as any oil, natural gas, or coal energy.
5 Renewable energy shall be defined as wind, hydro, solar, geothermal, and bioenergy.
6 Performance-based grants will be given based on the percent change of energy production
7 from fossil fuels to renewable energy.

8 SECTION 3. The Department of the Interior (DOI), the Energy Information
9 Administration (EIA), and the Environmental Protection Agency (EPA) shall be responsible
10 for the implementation of this legislation.

11 The DOI and the EIA shall work together to monitor the companies' shift to renewable energy
12 and determine the allocation of the grants. If a company uses the grants improperly, they shall
13 be retracted and the company will not be eligible for receiving grants for one (1) year.

14 The EPA shall be responsible for ensuring that companies are engaging in best practices for
15 shifting to renewable energy.

16 SECTION 4. This legislation shall come into effect 6 months upon passage. All laws in
17 conflict with this legislation are hereby declared null and void.
