

Fact Pattern:

State vs. Harper Thompson

In the quaint town of Willow Creek, a shocking theft of a priceless heirloom rocked the community on May 7th, 2023. The stolen property, a centuries-old diamond necklace known as the "Willow Creek Jewel," was a cherished possession of the town's historical society and held immense sentimental value.

Witness Statements:

Witness Statement 1: Prosecution - Detective Amanda Hayes
