

A Bill to Restrict Social Media use for minors

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

2. **Section 1** All individuals under the age of 18 who wish to create
3. and use a social media account must have their account linked to
4. a verified parental or guardian account. Additionally, device
5. verification will be required for minors to log in or access
6. social media platforms.

7. **Section 2** Social media websites are defined as websites and
8. applications that enable users to create and share content or to
9. participate in social networking.

10. **Section 3** If a user refuses to show verification of them being
11. over 18 years old or gaining parent permission they will be
12. taken off the platform until the requirements are met.

13. **Section 4** The federal Communication Commission will oversee the
14. regulation and enforcement of this bill

15. **Section 5** This law shall go into effect on June 1st, 2025

A Bill to Restrict the Use of Biometric Recognition Technology

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

2. **Section 1** The use of biometric recognition technology for
3. surveillance, identification, and tracking by federal, state, and
4. local government agencies shall be restricted to ensure the
5. protection of individual privacy rights and civil liberties. The
6. following restrictions shall apply to the use of biometric
7. recognition technology: a. Government agencies may only use
8. biometric recognition technology with a warrant or court order
9. based on probable cause. b. Biometric data collected by
10. government agencies must be stored securely and deleted within
11. 30 days if not used for investigative purposes. c. Biometric
12. recognition technology shall not be used in public spaces for
13. mass surveillance purposes.

14. **Section 2** "Biometric recognition technology" refers to systems
15. that identify individuals based on unique biological traits,
16. including but not limited to facial recognition, fingerprint
17. scanning, voice recognition, and iris scanning.

18. **Section 3** The Department of Justice (DOJ) shall be responsible for
19. overseeing the implementation and enforcement of these
20. restrictions, including the development of guidelines and
21. training for law enforcement agencies.

22. **Section 4** This bill shall take effect on January 1, 2026.

23. **Section 5** All other laws in conflict with this policy shall hereby
24. be declared null and void.

**A Bill to Restrict AI-Generated Imagery in
Published Media**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

2. **Section 1** The use of AI-generated images, music, or words in
3. advertisements shall be prohibited in all forms, including
4. digital, television, print, and social media advertisements. The
5. use of AI-generated images, music, or words in published works
6. shall be prohibited unless explicitly labeled as AI-generated
7. content.

8. **Section 2** AI-Generated images, music, and words are any artwork,
9. visual media, writing, or music created partially or entirely by
10. artificial intelligence algorithms, software, or machine
11. learning models. Advertising is any promotional material,
12. including digital, print, or audiovisual, created to market a
13. product, service, or idea. Published Works are media distributed
14. for public purchase and consumption, including books, magazines,
15. music albums, films, and online media platforms.

16. **Section 3** This bill will be overseen by the Federal Trade
17. Commission and the Federal Communications Commission. Violations
18. of this law will be subject to removal from advertising spaces
19. or prohibition of media sales.

20. **Section 4** This bill will come into effect on January 1st, 2027.

21. **Section 5** All laws in conflict with this legislation are hereby
22. declared null and void.

A Resolution to Support Supreme Court Term Limits

1. **WHEREAS**, Supreme Court justices currently serve life terms, which
2. can lead to prolonged tenure beyond the evolving social,
3. political, and legal landscapes of the nation; and
4. **WHEREAS**, the lifetime appointment of justices creates the potential
5. for decades-long influence on legal decisions, leading to
6. concerns about judicial accountability and public trust in the
7. judiciary; and
8. **WHEREAS**, the absence of term limits contributes to uncertainty
9. regarding the timing of judicial vacancies, leading to
10. politically charged nominations and confirmation processes that
11. harm the public's perception of judicial neutrality; and
12. **WHEREAS**, setting an 18-year term limit for Supreme Court justices
13. would ensure more regular and predictable vacancies, reduce
14. politicization, and encourage a more dynamic judiciary in line
15. with the changing needs of society; and
16. **RESOLVED**, Congress shall support an amendment to the Constitution
17. to impose an 18-year term limit for Supreme Court justices, with
18. current justices being grandfathered into the system to preserve
19. their lifetime appointments.

**A Bill to Ban Gifted and Talented
Education(GATE) Programs**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

2. **Section 1** Gifted and Talented Education (GATE) Programs will be

3. banned from being created and operated in public schools K-12.

4. **Section 2** GATE programs are defined as the creation of specialized

5. classes and support for "gifted and talent" (academically

6. advanced) students who receive harder coursework and specialized

7. support compared to the regular classes of their grade.

8. **Section 3** This bill will be overseen by the Department of

9. Education. Schools who do not abide by this bill can be subject

10. to a decrease in federal funding until programs are removed.

11. **Section 4** This bill shall take effect at the start of the

12. 2025-2026 Academic year.

13. **Section 5** All laws in conflict with this bill shall hereby be

14. declared null and void.
