

**A Bill to Limit Noise from Gas-Powered Leaf Blowers**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

2. **Section 1** The use of gas-powered leaf blowers shall be limited to  
3. certain hours in residential areas.

4. **Section 2** For the purposes of this bill: A. Gas-powered leaf  
5. blowers are tools that use gasoline engines to blow leaves and  
6. yard waste. B. They may only be used between 10:00 AM and 5:00 PM  
7. on weekdays.

8. **Section 3** Local governments will enforce the rules and may fine  
9. violators up to \$100.

10. **Section 4** This legislation will take effect on January 1, 2027.

11. **Section 5** All laws in conflict with this legislation are hereby  
12. declared null and void.

**A Bill to Ban Feeding Wild Animals in National Parks**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
2. **Section 1** It shall be illegal for visitors to feed wild animals in
3. any U.S. national park.
4. **Section 2** For the purposes of this bill: A. Wild animals include
5. any animals not kept as pets, such as bears, deer, raccoons,
6. birds, or squirrels. B. Feeding includes giving food directly,
7. leaving food out on purpose, or tossing food where animals can
8. reach it.
9. **Section 3** The National Park Service will enforce this law. Visitors
10. caught feeding wild animals will be fined \$250.
11. **Section 4** This legislation will take effect on July 1, 2026.
12. **Section 5** All laws in conflict with this legislation are hereby
13. declared null and void.

**A Bill to Ban Selling Pets from Puppy Mills**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
2. **Section 1** Pet stores shall be banned from selling dogs and cats
3. that come from puppy mills or large-scale breeding facilities.
4. **Section 2** For the purposes of this bill: A. Puppy mills are places
5. where dogs are bred in poor conditions, often without enough
6. space, food, or medical care. B. Pet stores may only sell animals
7. that come from shelters or rescue organizations.
8. **Section 3** The Department of Agriculture will enforce this law.
9. Stores that break this law will be fined \$2,500 for each violation.
10. **Section 4** This legislation will take effect on July 1, 2026.
11. **Section 5** All laws in conflict with this legislation are hereby
12. declared null and void.
