A Bill to Prohibit Testing on Animals

1 **SECTION 1.** Any company operating on U.S. soil, foreign or domestic is
2 prohibited from testing on animals.

3 **SECTION 2.** Animal testing is defined as any scientific experiment or test in
4 which a live animal is forced to undergo something that is likely to
5 cause them pain, suffering, distress or lasting harm.

6 **SECTION 3.** This bill will be enforced by the U.S. Department of Agriculture.

7 **SECTION 4.** This legislation will take effect on January 1st, 2020

8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Make Recess Longer

7 **SECTION 4.** This legislation will take effect on January 1st, 2020
